At the October 21, 2021 Annual Meeting, the Board stated that it would develop a Reserve Policy and place it for a vote of the membership sometime in 2022. The Board also indicated that there would be a second assessment in 2022 to begin funding the Reserve if approved by the community.

The Board has a duty to maintain the Common Assets of the Association and to plan for future major repairs However, the Board is asking for community feedback and support on this very important component of the annual budget.

Included in this mailing is a copy of the Reserve Policy that was approved by the Board of Directors. The policy outlines how the reserve funds will be collected, used, reported on and invested.

Because this vote is being conducted late this year, the Board is recommending a nominal amount of \$100 per lot to kick start the funding of the Reserve Account for 2022. A vote in favor of the Reserve Policy indicates approval of the \$100 assessment.
